### **A WARNING**

# **Operating Instructions**

#### TO RAISE:

Turn the handle clockwise until saddle contacts load. Continue turning handle to raise load to desired height.

### TO LOWER:

Turn handle counter-clockwise, make certain the load is secured before lowering.

## **Owner/User Responsibility**

The owner and/or user must have an understanding of the manufacturer's operating instructions and warnings before using this under hoist stand. Personnel involved in the use and operation of equipment shall be careful, competent, trained, and qualified in the safe operation of the equipment and its proper use when servicing motor vehicles and their components.
